



## Model Rules 2.0 and the Co-op Act: A Reference Table

This reference table links Model Rules 2.0 to the relevant sections of the *Cooperative Association Act* SBC 1999, Chapter 28 and the *Cooperative Association Regulation* BC Reg. 391/2000. The section numbers are up to date as of February 5, 2014, for the Act and February 13, 2014, for the Regulation. The numbering may change if the Act is changed in the future. Not all relevant sections of the Act are listed here.

This list is to help you look in the Act for more information. You don't need to know this information in detail to use the Model Rules. You can also read CHF BC's Guide to the *Co-op Act*.
